Arbitration

Civil disputes between the following organizations and persons are subject to arbitration to the exclusion of ordinary jurisdiction:

- a) the SAFV,
- b) the SAFV member clubs,
- c) the cantonal and regional associations of the SAFV,
- d) the licensed persons of the SAFV (if the disputes arise from the capacity as licensed persons of the SAFV).

Disputes subject to arbitration shall be submitted for decision to a sole arbitrator of the Court of Arbitration for Sport with its seat in Lausanne. The right to appeal against the decision is expressly waived, subject to mandatory law. In all other respects, the rules and regulations of the Court of Arbitration for Sport shall apply.

Anyone applying for a license of any category thereby gives his irrevocable consent to this arbitration clause.

Compliance with the statutes and regulations of the SAFV

Whoever applies for a license of any category expresses that he/she will fully comply with the respective valid statutes, regulations, ordinances and other rules of the SAFV (subject to mandatory law). These are available to every member club of the SAFV and can be viewed and downloaded at www.safv.ch.

Untrue information in the license application may result in disciplinary sanctions for both the licensee and his/her club.

Liability and insurance

Whoever applies for a license of any category expresses that he/she has sufficient insurance coverage for the sport of American Football.

The applicant acknowledges that he/she cannot hold the SAFV and its officials liable for illnesses or accidents resulting from the practice of the sport. Mandatory law remains reserved.

Privacy policy

Data protection is a high priority for the SAFV. Accordingly, SAFV endeavors to handle all data collected with care and observes the provisions of the Swiss Data Protection Act (DSG) when collecting and processing data.

The purpose of personal data and related files such as images used by SAFV is personal, license, statistics and results management, use for general correspondence and to bring news and information about services to the attention.

The purpose gives SAFV the following rights:

- Statistical analysis and processing, as well as informing the public about the findings;
- Publication of personal data on a website, namely: first name, last name, gender, date of birth, height, weight, sports association, position.
- Publication of personal data in the form of media releases. These can also be posted on the SAFV website.

The SAFV does not pass on personal data to third parties for commercial purposes. The disclosure of personal data for processing to third parties for non-commercial purposes is permitted if the task has been assigned to the third party by agreement or the disclosure is provided for by law. The data will be processed by the third party only to the extent that SAFV itself would be permitted to do so and no legal or contractual obligation of secrecy would prevent this.
